Article 1 Subject

1.1 The subject of the contract shall be:

the supply, delivery and training 3 workers from PUC"Vodovod" Kraljevo, of the following supplies:

• CANAL JET VEHICLE WITH EQUIPMENT - specialized canal jet vehicle equipped with high pressure pumps and vacuum pumps (1 pc)

The place of acceptance of the supplies shall be PUC "Vodovod" Kraljevo, the time limits for delivery shall be 6 months and the Incoterm applicable shall be DDP⁴. The

implementation period of tasks shall run from the date of contract signature by both parties to to <date for provisional acceptance>.

- 1.2 The contractor shall comply strictly with the terms of the special conditions and the technical annex.
- 1.3 The supplies which form the subject of the contract must be accompanied by the spare parts described by the contractor in its tender [and by the accessories and other items necessary for using the goods over a period of, as specified in the instructions to tenderers.

Article 2 Origin

The rules of origin of the goods are defined in Article 10 of the special conditions.

When required, a certificate of origin for the goods must be provided by the contractor at the latest when it requests provisional acceptance of the goods. Failure to comply with this condition may result in the termination of the contract and/or suspension of payment.

Article 3 Price

- 3.1 The price of the supplies shall be that shown on the financial offer (specimen in Annex IV). The total maximum contract price shall be [EUR] [RSD < insert price>
- 3.2 Payments shall be made in accordance with the general and/or special conditions (Articles 26 to 28).

Article 4 Order of precedence of contract documents
